Vans and minivans procured with FTA funds require that: (1) the costs of components and subcomponents produced in the United States is more than 70 percent of the cost of all components of the vehicle (domestic content requirement); and (2) final assembly of the vehicle has occurred in the United States (final assembly requirement). 49 U.S.C. 5323(j)(2)(C); 49 CFR § 661.11. On a procurement-by-procurement basis, van and minivan manufacturers must agree to an audit that includes: (1) a listing of the vehicle's component and subcomponent parts, including their country of origin and costs; and (2) a description of the location of the final assembly point for the rolling stock, including a description of that activities that will take place at the final assembly point and the cost of final assembly. 49 U.S.C. 5323(m); 49 CFR Part 663. As such, while FTA does not specify any specific manufacturing processes: (1) 70 percent, by cost, of van or minivan components (those items directly incorporated into the vehicle at the final assembly location) and subcomponents (those items one step removed from a component) must be manufactured in the United States; and (2) The van or minivan must undergo final assembly in the United States.
Provide dimensions / size / tolerances / performance specifications of the item	For purposes of this search, FTA defines van or minivan to include unmodified "passenger motor vehicles" (as that term is defined by the Automobile Labeling Act) with seating capacity for at least six adults not including the driver. The America Automobile Labeling Act defines "passenger motor vehicle" to include motor vehicles designed to carry not more than 12 persons with a gross vehicle weight rating not greater than 8,500 pounds and includes multipurpose passenger vehicles and light duty trucks.
